

Evaluation Product Purchase Agreement for Intercom

THIS PAID EVALUATION PRODUCT PURCHASE AGREEMENT (“Agreement”), dated as of [] (“Effective Date”), is entered into between **Hikvision USA Inc.**, a corporation incorporated under the laws of the State of California and having its principal office at 18639 Railroad St, City of Industry, CA 91748 (“Hikvision” or the “Company”) and the following customer (the “Customer”).

WHEREAS, Customer is interested in the following Hikvision products (“Evaluation Products”) and desires to purchase the Evaluation Products and Hikvision desires to sell such Evaluation Products to the Customer, subject to the terms and conditions of this Agreement.

NOW THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Customer’s Representation:

Sales Tax Exemption: Customer represents and certifies that all material, merchandise, or goods purchased by the Customer from Hikvision after the Effective Date are purchased for the following purpose:

- Sale, as is, in Customer’s regular business operations
- Sale as a physical part of another product, or
- Use for demonstration or display while holding it for sale in Customer’s business

Customer acknowledges and agrees that the above representation and certification shall be incorporated into each purchase order placed by Customer and shall continue in force until being revoked by the Customer. **Customer shall provide Hikvision with a valid seller’s permit and resale certificate at the time of placing the purchase order to avoid being charged sales tax.** Customer assumes full responsibility for remitting state sales taxes as appropriate and Hikvision will not invoice for such taxes as indicated by the seller’s permit and resale certificate provided.

No Sales Tax Exemption: Customer represents and certifies that it doesn’t have a valid seller’s permit and resale certificate at the time of placing the purchase order and agrees that Hikvision shall invoice sales taxes as appropriate.

2. Evaluation Products: For a list of eligible products see product list page. **Please fill in the quantity for each available model, limit five (5) per model per customer.** Hikvision agrees to pay for ground shipment and ship the Evaluation Products to the following address:

3. **Purchase Order Subject to Acceptance of Hikvision:** Upon receipt of this Agreement signed by the Customer, Hikvision will notify Customer of approval within 72 hours from the date of receipt, through execution of this Agreement.
4. **Payment:** Customer agrees to be charged for the amount incurred under this Agreement at the time of shipment of the above Evaluation Products.
5. **Trial Period and Return for Credit:** Hikvision agrees to provide a 45-day trial period for the above Evaluation Products, commencing from the date of delivery (“Trial Period”). If Customer desires to return the Evaluation Products for full credit, Customer must (1) return the Evaluation Products prior to the expiration of the Trial Period, through Hikvision’s RMA policy available at <https://us.hikvision.com/en/support-resources/warranty-rma/rma-policy>; (2) include the RMA Number on the outside of the box; and (3) ensure that the returned Evaluation Products are defect free and packaged in the original carton(s). Upon Hikvision’s receipt and verification of the returned Evaluation Products, full credit will be returned to the original purchaser.
6. The Evaluation Products shall be provided solely on an “as-is” basis. Regarding to the Evaluation Products with internet access, the use of the Evaluation Products shall be wholly at the Customer’s own risks. Hikvision shall not take any responsibility for abnormal operation, privacy leakage or other damages resulting from cyber attack, hacker attack, virus infection, or other internet security risks.
